Unidentified objects



BOARD OF DIRECTOR'S MEETING OF THE PINON HILLS CHAMBER OF COMMERCE, FEBRUARY 9, 1973

The February meeting of the Board of Directors of the Pinon Hills Chamber of Commerce was called to order by President Katherine Hand at 8:00 P.M. Friday February 9th at the home of the Dobbs.

Secretary's minutes were read and approved.

A limited Treasurer's report was acquired from the absent Treasurer Alice Judge and our balance was tentatively figured with a deficit of \$ 145.47

Frank Jones agreed to correct some of the water situations in the Chamber of Commerce building and he would add a lock to the exposed upright pipe in the back, in lieu of reported water theft.

Mr. Goulet announced a talk by Mr. Kenneth Hanna, a bank executive, on the pitfalls of estate makers, for the February Chamber of Commerce meeting.

It was decided to try a chartered bus trip to the Queen Mary in ^{March} February. Some of the details remained to be worked out. The Queen Mary was chosen by the board from several possible trips.

The Food was scheduled for the February 24th Chamber of Commerce meeting. 5 persons would bring cherry pies and one would come up with the whipped cream.

Mr. Mudge was not present to report on his Hospitality calls but he did report well the following day on his attempts to contact the Waters, Penn, Hellman and Bachelers.

Mrs. Leger in the absence of her husband Elmo, suggested that we have an emergency service where an emergent call of some citizen of the community could be answered. It was established that the Leger phone, 6581 and Mrs Hand's phone 3559 would be made available. Mrs Leger also suggested that the Chamber building be used on various days by people who are interteded in playing cards, keeping up the first aid, a library, and meeting for hiking when the weather permitted. and the kitchen above all could use a paint job.

It was mentioned that frequent opening of the building could develop into over running of the building by unauthorized perssonel if not watched carefully.

Kathryn Jones suggested that we again use a bulletin board at the Real Estate office announcing our various activities. This process had been effective at one time.

The meeting of the Fire Department Committee was announced for Wednesday night, February 14th at 7:30 P.M.

The Tri-Committee meeting which meets at wrightwood was mentioned. This Committee discusses related activities in general between, Pinon Hills, Wrightwood and Phelan. A representative from here was not named.

A bake sale was announced for April the 14th to raise funds for the street light.

The hiking club has been reactivated and a jaunt was taken to see the local wild flowers.



Della Goulet offered the refreshments for the June 8th Board meeting.


Fire Chief Bray would be asked to display the new ambulance at the June 23rd Pot Luck Dinner.
