January 27, 1978


The meeting was called to order by President Lou Paulsen following the Pot Luck at 7:00 P.M.


President Paulsen then proceeded to announce that Doug Douglas will introduce our guest speaker.



August 25, 1978


The meeting was called to order by First Vice President Jon Kaylor, in absence of President Paulsen at 7:45 PM following the Pot Luck.

Nominations of officers for the year 1979 were submitted by the committee of elections. Elections were held on each individual office and then on 4 members of the board of directors with the following selection.



After years of paying for the street light at Mountain Road and 138, and numerous attempts at getting the State or County to take it over, persistence finally paid off and with the help of Larry Chimboli, assemblyman, the Chamber was finally relieved of this burden on June 1st.

In June the High Desert Property Owners donated \$250.00 to the Building Fund and an account was opened at ~~the~~ Home Savings and Loan. This was augmented by \$85.00 netted from an Ice Cream social in July sponsored by the Pinoneers, under the direction of Jewel Lee. Hilly Kaylor headed the entertainment, which was excellent.

In November the Pinoneers donated \$152.00 from the bake sale held at the little building near the market which had been painted and draped by Sandy Francis. Myrtle Grant donated one of her paintings which netted \$35.00 for the treasury.

With all the new appliances and furnishings the first Xmas party ever held at the Chamber was a must. An upside down Xmas tree made from juniper knocked down by the water pipe installers, table and wall decorations and exchange of gifts added to the festivities of a pot luck dinner with ham, punch and rolls donated by the Pinoneers.

Thru the efforts of Mr. Huston, County Engineer, and cooperation of the Chamber, the Zone L water office, community building and new fire building will be built in the near future - with the water office scheduled to be completed by June 30th.

Chamber members have been active in attending water meetings, block grant meetings. Jewel and Damon Lee were most responsible on the water committee. Helen Christman and Kathryn Jones have been active in working for a new T.V. translator. Emily Leger has attended meetings for senior citizens as well.

Bake sales and other fundraising activities will be held in the future to assist in retiring the bonds. The \$300.00 from the Economic Development Department has again been accepted for the purpose of putting on a dinner such as the spaghetti dinner and pancake breakfast from the 1977 donation. This dinner will be held some time this spring.

The Chamber will continue to do what it can to promote the welfare of the Community and to encourage improvements.
